PRELIMINARY RED FLAG INVESTIGATION

Introduction

The purpose of this section is to provide additional data, graphics, and analyses regarding the potential impacts by the project alternatives to hazardous material concerns.


The National Environmental Policy Act (NEPA) established the framework to consider how federal actions may have an impact on the environment. From this framework, the Council on Environmental Quality (CEQ) provided the opportunity for major transportation actions processed as an EIS to be tiered (40 CFR 1508.28: Tiering). Tiering separates the broader issues such as selection of the general location and mode choice in Tier 1 from the more detailed site-specific impacts in Tier 2. For large, complex transportation projects tiering is beneficial for both the lead federal agency providing approval and the lead state agency planning the transportation improvement. With tiering, the Tier 1 DEIS allows the focus to be on approving the purpose and need and determining the most appropriate broad corridor. The purpose in Tier 1 is to obtain enough information to present reasonable estimates for comparison of alternatives in the decision-making process. If the outcome of Tier 1 is a build alternative, then Tier 2 environmental documentation will continue and capture the specific detail of impacts within the selected corridor as the engineering design is refined.


Summary

This Tier 1 analysis was conducted from a preliminary standpoint using the standard INDOT environmental process used for Red Flag Investigations (RFI's). This Tier 1 desktop analysis was conducted by searching for all DOT hosted hazardous materials concerns within a half mile radius of the Alternatives and Local Improvement alignments. Local Improvements 3 and 4 were given a 500 foot search radius due to the increased number of hazmat concerns associated with the City of Jasper. Additional detailed hazardous material concerns analysis will be conducted during the Tier 2 investigations.

1.0 INTRODUCTION AND BACKGROUND

The National Environmental Policy Act (NEPA) established the framework to consider how federal actions may have an impact on the environment. From this framework, the Council on Environmental Quality (CEQ) provided the opportunity for major transportation actions processed as an Environmental Impact Statement (EIS) to be tiered. Tiering separates the broader issues, such as selection of the general location and mode choice in Tier 1 from the more detailed sitespecific impacts in Tier 2. APEC performed a preliminary environmental site assessment (ESA) screening for a Tier I Environmental Impact Statement (EIS) for the Mid-States Corridor Project (Study Area). The environmental process for this project is currently in the Tier 1, alternative analysis stage of assessment. As the project progresses through Tier 1 and Tier 2, alignment alternatives will be eliminated and additional investigations (i.e. Red Flag Investigations, ESA, and Limited Site Investigations) will be undertaken on the preferred alternative. This ESA is the initial step in the alternative analysis stage of assessment. The purpose of the assessment was to quantify the potential effects of properties within the Study Area and/or adjacent property hazardous materials operations on the Study Area corridors, as shown in Figure 1. Properties identified within or adjacent to the Study Area with the potential to negatively affect the subsurface within the Study Area were identified as Properties of Concern. Early identification of Properties of Concern can help to reduce future environmental liability, identify and address potential future health and safety concerns associated with construction worker exposure, and reduce the potential for increased construction costs associated with the disposal and management of unexpected, contaminated materials.

Properties of Concern were identified based on factors including (but not limited to):

- The known current and/or historic use of the property
- The known or likely presence of hazardous materials at the property currently or historically
- The presence of the property within local, state, or federal environmental databases and the nature of such listings
- Known past or present environmental problems or environmental investigations associated with the property and the current status of the problem/investigation
- The inferred local groundwater flow direction

Identified Properties of Concern were further evaluated for their potential to have negatively affected the subsurface within the Study Area and were given a Level of Concern classification (Low, Medium, or High). The low, medium, and high levels of concern are defined below:

Level of	Definition
Concern	
Low	Unlikely to have negatively affected the Study Area. This includes properties that have had historic environmental problems that have since been resolved, properties that have hazardous materials contained using upgraded containment and leak detection systems, and properties that have no indication of environmental impact
Medium	Possible, to likely, to have negatively affected the Study Area. This includes properties that are currently undergoing an environmental investigation, violations have historically been filed, hazardous material containment systems are old, and properties that require additional investigation to verify absence or presence/extent of contamination
High	High likelihood, to definite impact, to the Study Area. This includes properties that have known contaminant concentrations above regulatory screening levels or evidence that contamination is highly likely to be present but not yet verified. This includes sites where contamination is known to have extended into the Study Area.

2.0 METHODOLOGY

The Study Area for this preliminary ESA is a half mile buffer from the centerlines of the various alternatives and local improvements, however, the Study Area for local improvements 3 and 4 used a buffer of 500 feet due to the density of the Jasper, Indiana area. Publicly available GIS layers containing sites with potential to impact the subsurface were compiled from Indiana Department of Environmental Management (IDEM), Indiana Department of Transportation (INDOT), and United States Environmental Protection Agency (USEPA) databases. GIS represented sites have been mapped in the various databases. Selected layers acquired included:

- Brownfields sites,
- State Cleanup sites,
- Voluntary Remediation Program (VRP) sites,
- Properties with institutional controls on the deed (i.e. Environmental Restrictive Covenants),
- Landfills, antique landfills, and waste disposal sites,
- RCRA Generator/Transportation, Storage, and Disposal (TSD) facilities,
- RCRA Corrective Action sites,
- Manufactured Gas Plants,
- Open Dump Waste sites,
- Restricted Waste sites,
- Tire waste sites,
- Confined Feeding Operation sites,
- Superfund sites,

- Underground Storage Tanks (USTs),
- Leaking Underground Storage Tanks (LUSTs),
- IDEM OLQ Program sites,
- National Polluant Discharge Elimination System (NPDES),
- Assessment Cleanup and Redevelopment Exchange System (ACRES) sites,
- Superfund Enterprise Management System (SEMS) National Priorities List (NPL) sites,
- and Toxic Release Inventory (TRI) facilities.

Some facilities may not be mapped within the various GIS layers; therefore, additional sites were identified via a visual inspection of the alignment boundaries using aerial imagery. Sites located within the alignment boundaries were selected and investigated using IDEM's Virtual File Cabinet and public compliance reports. The Study Areas and identified sites are shown on **Figure 2a** through Figure 2f.

3.0 ANALYSIS

Based on the ESA conducted by **APEC** utilizing the methodologies and strategies noted above, a total of 75 Properties of Concern were identified within or adjacent to the new Study Area. General information about each property of concern is outlined in **Table 1**. In addition to the 75 Properties of Concern, a total of 76 NPDES sites and 25 NPDES pipe locations were identified within or adjacent to the new Study Area. Information concerning NPDES sites is outlined in **Table 3a** and **Table 3b**. All of the identified NPDES sites are considered to have a low level of concern.

This ESA will identify properties with low, medium, and high levels of concern; however, as the project progresses into Tier 2, additional investigations will be undertaken for the preferred alternatives. Properties identified with a low level of concern are unlikely to contain contaminant concentrations that can present a concern in handling, transport, or disposal of waste. Properties identified with a medium and high level of concern have a more concerning level of likelihood to contain contaminant concentrations that can present a concern in handling, transport, or disposal of waste. Medium and high level of concern properties are discussed in greater detail below.

3.1.2 Medium Level of Concern Status

Site 35- Circle A 115 (AI ID 2167) (7136 N US 231, Jasper, IN)

The user systems were installed in 1979 and utilize fiberglass piping. A IDEM inspection was performed at the facility in 2016 and violations associated with recordkeeping were reported. No additional inspections have taken place since 2016; and it is unknown if the facility returned to compliance following the 2016 inspection. This site was given a medium level of concern based on the longevity that user have operated at the property and the potential for undocumented releases to have negatively affected the Study Area. This property is labeled as 35 on **Figure 2c** and **Table 2c**.

Site 42-Northside Citgo (Al ID 1941) (2707 Newton St., Jasper, IN)

The above facility currently operates two 10,000-gallon gasoline USTs with associated piping. The USTs are made of steel and were installed in 1984. The UST system piping is made of reinforced fiberglass, however, the piping was originally constructed of steel and was upgraded to fiberglass at an unknown time. The facility received a violation letter in September 2020 following a routine IDEM inspection. The violation letter noted a corroded spill bucket and failure to provide UST corrosion protection results and various forms of documentation. IDEM issued a return to compliance letter to the facility on January 4, 2021. This site was given a medium level of concern based on the age and construction of the UST system and the likelihood of undocumented releases to negatively affect the Study Area. This property is labeled as 42 on **Figure 2e** and **Table 2e**.

Site 50-Veterans of Foreign Wars Post 673 (Al ID 2624) (1907 Newton St., Jasper, IN)

The above facility previously operated a heating oil UST. The reviewed document in IDEM's VFC provides two UST forms with differing information. Based on the information reviewed, the UST is made of steel with likely steel piping. Its size is either 500 or 2,000 gallons and was installed sometime between the 1940s and 1960s. The heating oil UST was last used in 1985 before the facility converted to natural gas heating. The UST was reportedly closed in-place by filing with sand. No further information regarding the heating oil UST is provided. This site was given a medium level of concern based on the likely age and known construction of the UST system, the presence of differing information and lack of additional information regarding the UST system, and the likelihood of undocumented releases to negatively affect the Study Area. This property is labeled as 50 on **Figure 2e** and **Table 2e**.

Site 51-Circle A Food Mart 105 (Al ID 5624) (1402 N. Newton St., Jasper, IN)

The above facility currently operates five USTs. The USTs are constructed of fiberglass and were installed in 1988 with pressurized fiberglass piping. Two USTs were previously installed in 1955 and were closed in-place in 1988. An October 2020 IDEM inspection of the facility noted violations associated with record keeping, however, the facility quickly returned to compliance that same month. This site was given a medium level of concern based on the age of the current UST system, general longevity that UST systems have been operated at the property, and the likelihood of undocumented releases from the current or previous UST systems to negatively affect the Study Area. This property is labeled as 51 on **Figure 2e** and **Table 2e**.

Site 53-Bonhert Shell (Al ID 4609) (902 Newton St., Jasper, IN)

The above facility previously operated a UST system at the listed address. Soil and groundwater petroleum contamination were discovered at the property in 2006. In 2011, the UST system was removed along with approximately 1,674 tons of petroleum contaminated soil and 14,443 gallons of petroleum contaminated groundwater. Groundwater monitoring and sampling took place at the property until 2014 when a conditional No Further Action (NFA) was granted by IDEM. An Environmental Restrictive Covenant (ERC) was placed on the Subject Property to limit exposure to petroleum contaminated groundwater left in-place. Low-level benzene concentrations were observed in a monitoring well near Newton Street prior to issuance of the NFA in 2014. This site was given a medium level of concern based on the likely presence of low-level petroleum groundwater contamination immediately adjacent to the Study Area. This property is labeled as 53 on **Figure 2e** and **Table 2e**.

Site 62-Guarantee Auto (Al ID 3640) (34 Wernsing St. Jasper, IN)

The above facility previously operated a 550-gallon steel used oil UST installed in approximately 1984. There is no information to suggest the UST was removed from the property. An IDEM inspection was conducted at the facility in 1998. The inspection report indicates that the owner of the property at the time of the 1998 inspection was unaware that a UST was present at the property. No further information is available regarding the UST. This site was given a medium level of concern based on the lack of information regarding the property and the potential for petroleum contaminants to have been released at the site

and have negatively affected the Study Area. This property is labeled as 62 on **Figure 2e** and **Table 2e**.

Site 63-Ruxer Ford Lincoln Mercury (Al ID 879) (123 Place Rd., Jasper, IN)

The above facility previously operated six USTs. The six USTs were constructed of steel and installed in approximately 1980. Five of the USTs had a 550-gallon capacity and one UST had a 1,120-gallon capacity. The USTs were reportedly utilized to store transmission fluid, motor oil, and one was used to store water. The UST system piping was constructed of galvanized steel. According to a UST notification form, the USTs were removed in August 1988. No further information regarding the historic UST system or its removal is available. Furthermore, the Ruxer Ford facility was listed as a small quantity generator of hazardous waste in 2002. An IDEM inspection conducted at the facility in 2002 noted violations associated with the documentation of hazardous waste quantities. The inspection report notes that the facility utilizes a 30-gallon sump for used oil storage which is then pumped to a 2,000-gallon steel Aboveground Storage Tank (AST). An oil water separator is also utilized in the shop area. Waste paint and solvent are generated as hazardous waste and hauled offsite by a third-party waste hauler in 55-gallon drums. The facility received a return to compliance letter from IDEM in January 2003. No further public information is available for review. This site was given a medium level of concern based on the lack of information regarding the six UST removals and the lack of information associated with the facility's hazardous and non-hazardous waste generation and storage since IDEM's 2002 inspection. Given the reviewed information, the potential exists for hazardous or petroleum contaminants from current or historic operations at the property to have negatively affected the Study Area. This property is labeled as 63 on Figure 2e and Table **2**e.

Site 64-Jasper Engine Exchange Inc. (Al ID 15692) (815 Wernsing Rd., Jasper, IN)

The above facility previously operated two 550-gallon used oil USTs that were removed in 1990. One diesel steel UST and one used oil steel UST were installed at the property in 1988 and were removed in 2016. During the UST removal in 2016, a historic release was discovered, and LUST number 201602521 was issued to the site, however, an unconditional NFA was granted to the site in March 2016. The site is also listed as a small quantity generator of hazardous waste (mostly chromium contaminated waste). A cleanup of lead and chromium contamination in soil was performed at the property in 1982 under the direction of the EPA. The 1982 cleanup was granted a No Further Remedial Action Planned (NFRAP) by the EPA. A compliant IDEM inspection was performed at the facility in 2018. This site was given a medium level of concern based on the longevity that hazardous and non-hazardous waste has been generated at the property and the potential for undocumented releases to have negatively affected the Study Area. This property is labeled as 64 on **Figure 2f** and **Table 2f**.

Site 65-Sternberg Inc. (Al ID 1547) (1781 S. US 231, Jasper, IN)

The above facility currently operates ten USTs. Three USTs are 10,000-gallon fiberglass tanks for storing gasoline, two USTs are 12,000-gallon fiberglass tanks for storing diesel fuel, two USTs are 2,000-gallon fiberglass tanks for storing new oil, and two USTs are 1,000-gallon fiberglass tanks used for storing used oil. The fuel USTs were installed in

2005 and utilize pressurized fiberglass piping with automatic leak detection and automatic shutoff mechanisms. The oil UST systems were installed in 1986 and utilize fiberglass suction piping. A compliant IDEM inspection was performed at the facility in 2015. A violation letter was issued to the facility in 2017 associated with recordkeeping, however, the facility returned to compliance in 2018. This site was given a medium level of concern based on the quantity of USTs present at the property, the longevity that USTs have operated at the property, and the potential for undocumented releases to have negatively affected the Study Area. This property is labeled as 65 on **Figure 2f** and **Table 2f**.

Site 67- Dubois County Collection Container System (AI ID 6262) (1701 N. Van Buren St., Jasper, IN)

The above facility currently operates three 6,000-gallon fiberglass USTs, two containing diesel and one containing gasoline. The UST systems were installed in 1991 and utilize fiberglass piping. A IDEM inspection was performed at the facility in 2016 and violations associated with recordkeeping were reported. No additional inspections have been documented at the facility since the 2016 inspection; and it is unknown if the facility returned to compliance following the 2016 inspection. This site was given a medium level of concern based on the longevity that USTs have operated at the property, and the potential for undocumented releases to have negatively affected the Study Area. This property is labeled as 67 on **Figure 2f** and **Table 2f**.

Site 68-Circle A 111 (Al ID 4701) (1921 S. Lube Way, Jasper, IN)

The above facility currently operates seven USTs. All seven USTs are constructed of fiberglass (two are double-walled fiberglass). The USTs are utilized for gasoline and diesel fuel storage. The UST system piping consists of double-walled fiberglass pipes. Six USTs were installed in 2001 and one UST was installed in 2006. The facility received a violation letter in 2019 following a routine IDEM inspection in which the inspector cited water and fuel in the tank pit sumps and fluids in the dispenser containments. This site was given a medium level of concern based on the quantity of USTs present at the property, the longevity that USTs have operated at the property, and the potential for undocumented releases to have negatively affected the Study Area. This property is labeled as 68 on **Figure 2f** and **Table 2f**.

Site 71- Dubois County Concrete Products Incorporated (AI ID 9085) (1701 N. Van Buren St., Jasper, IN)

The above facility previously operated two USTs, one 10,000-gallon fiberglass diesel UST installed in approximately 1974 and one 1,000-gallon steel gasoline UST installed in approximately 1963. The USTs were removed in December 1988, however, no closure samples were collected. No further information regarding the historic UST system or its removal is available. Furthermore, the facility was listed as a small quantity generator of hazardous waste in 2008. This site was given a medium level of concern based on the lack of information regarding the two UST removals and the lack of information associated with the facility's hazardous and non-hazardous waste generation and storage since 2008. Given the reviewed information, the potential exists for hazardous or petroleum contaminants from historic operations at the property to have negatively affected the Study Area. This property is labeled as 71 on **Figure 2f** and **Table 2f**.

3.1.3 High Level of Concern Status

Site 7- Alfordsville Gas Station (16272 US 231 N, Loogootee, IN)

The above facility previously operated one 9,000-gallon and one 3,000-gallon USTs with associated piping. Both USTs were made of steel and were installed in 1999. The facility ceased operation of the UST system in 2018. Several violations associated with the UST system were noted in 2010, 2013, and 2020. The facility has remained abandoned since 2018. The facility's UST system and associated piping were removed in April 2021. Confirmatory sampling conducted during UST removal activities revealed petroleum contaminants present in groundwater. No petroleum contaminants were discovered in soil. Due to the presence of contaminated groundwater at the site, IDEM issued LUST incident number 202104517 to the site. The LUST incident number is still open, and the site is believed to be under an active investigation. This property was given a high level of concern based on the known presence of groundwater contamination directly adjacent to the Study Area and the likelihood of the recently documented release to have negatively affected the Study Area. This property is labeled as 7 on **Figure 2a** and **Table 2a**.

Site 41-Jasper Corporation (Al ID 669) (2704 N. Newton St., Jasper, IN)

The above facility previously operated two USTs at the property. One UST was a 6,000-gallon gasoline steel UST installed in approximately 1958. The other UST was a 3,000-gallon steel UST used to store hazardous material and was installed in approximately 1963. Both USTs were reportedly removed from the ground in September 1987. There is no public information available indicating if UST closure samples were collected at the time of removal. The facility operated as a large quantity and small quantity hazardous waste generator during its operation until the business closed in 2002. The property is now utilized for a museum. This site was given a high level of concern based on the lack of information associated with the 1987 UST removals, the longevity that hazardous and petroleum UST systems were operated at the facility, the longevity that large and small quantities of hazardous waste was generated at the property, and the likelihood for undocumented releases of hazardous and petroleum products to have negatively affected the Study Area. This property is labeled as 41 on **Figure 2e** and **Table 2e**.

Site 49-Marathon (Tobacco Road 96) (Al ID 5446) (1908 N. Newton St., Jasper, IN)

The above facility currently operates three USTs (15,000-gallon, 6,000-gallon, and 4,000-gallon) installed in 2016. The USTs are made of steel with a fiberglass jacket and are used to store gasoline and diesel. The UST system piping is constructed of double-walled fiberglass and is equipped with automatic leak detection and automatic shutoff mechanisms. Prior to the installation of the current UST system, three USTs at the property were closed in place and nine soil borings were advanced at the site as part of the in-place closure activities. Petroleum contaminated soil and groundwater was discovered during soil boring activities and a confirmed release was reported to IDEM and incident number 201602518 was assigned to the site. Site characterization and investigation activities took place at the site in 2016 and 2018 and quarterly groundwater monitoring and sampling has been performed at the site since 2016. Based on the Third Quarter 2021 Quarterly Monitoring Report dated October 25, 2021, shallow groundwater contamination is present onsite in close proximity to US 231. Quarterly groundwater monitoring and sampling activities are still ongoing at the site. This site was given a high level of concern based on

the known presence of shallow petroleum groundwater contamination immediately adjacent to the Study Area. This property is labeled as 49 on **Figure 2e** and **Table 2e**.

The above-mentioned facility currently operates three fiberglass USTs installed in 1985 and one steel UST installed in 1981. The facility was issued a violation letter in September 2020 associated with record keeping violations, failure to perform leak detection testing, and failure to perform cathodic protection inspections. There are no documents which indicate that the facility has returned to compliance. This property was given a medium level of concern based on the age of the UST system, previously noted violations, lack of UST system upgrades, and the likelihood of undocumented releases to negatively affect the Study Area. This property is labeled as 10 on **Figure 2b** and **Table 2b**.

Site 11- Priscilla Cessna Property (3527 State Road 37, Mitchell, IN)

Based on a review of historical aerial photographs, the above property appears to have been utilized as a dump since at least 2005. Several abandoned vehicles, semi-trailers, and piles of refuse are visible in multiple aerial photographs. This site was given a medium level of concern based on the lack of information regarding the property and the potential for automotive related contaminants to have been released at the site and have negatively affected the Study Area. This property is labeled as 11 on **Figure 2b** and **Table 2b**.

The above facility currently operates three steel USTs, one 10,000-gallon gasoline, one 6,000-gallon diesel, and one 6,000-gallon gasoline. The UST systems were installed in 1989 and utilize fiberglass piping. A IDEM inspection was performed at the facility in 2020 and violations associated with recordkeeping were reported. In January 2021, the site was issued a return to compliance letter. This site was given a medium level of concern based on the longevity that USTs have operated at the property and the potential for undocumented releases to have negatively affected the Study Area. This property is labeled as 13 on **Figure 2b** and **Table 2b**.

The above facility previously operated a UST system at the listed address. Soil and groundwater petroleum contamination were discovered at the property in 2004 during UST removal activities. In July 2009, a conditional NFA was granted to the site by IDEM. An Environmental Restrictive Covenant (ERC) was placed on the Subject Property to limit exposure to low-level petroleum contaminated groundwater left in-place. This site was given a medium level of concern based on the likely presence of low-level petroleum groundwater contamination immediately adjacent to the Study Area. This property is labeled as 19 on **Figure 2c** and **Table 2c**.

3.4.3 High Level of Concern Status

The above facility currently operates three steel USTs installed in 1994. Two USTs are 2,000-gallon gasoline tanks and one is a 1,000-gallon diesel tank. The UST system piping is constructed of fiberglass and utilizes suction for fuel transport from the tanks to the dispensers. LUST number 201809509 was assigned to the site when light non-aqueous phase liquid (LNAPL) was observed in the tank pit monitoring well. Site characterization and investigation activities took place 2018 through 2020. LNAPL recovery and quarterly groundwater monitoring and sampling have been conducted at the property since at least 2020 and are ongoing. The most recent quarterly monitoring report for the site (Fourth Quarter 2021 Groundwater Monitoring Report dated December 3, 2021) indicates benzene and naphthalene groundwater contamination at concentrations exceeding regulatory screening levels is present beneath the State Road 56 and State Road 545 intersection and near vicinity. Multiple monitoring wells associated with quarterly groundwater monitoring activities at the site exhibit increasing contaminant concentrations. Based on the conclusions of the Fourth Quarter 2021 Groundwater Monitoring Report, A Corrective Action Plan (CAP) for the site has not been developed and the site will continue to undergo quarterly monitoring activities. This site was given a high level of concern based on the known presence of subsurface contaminants in the Study Area. This property is labeled as 37 on **Figure 2d** and **Table 2d**.

4.0 MITIGATION

As the information found in this investigation will be utilized in the Tier 1 environmental review of the project, specific details of mitigation have not yet been determined. The information within this document will aid in the selection of a preferred alternative, at which time additional investigations will be undertaken. Details of these actions will be determined during Tier 2 studies.

5.0 CONCLUSIONS

Based on APEC's review of the provided alternatives and local improvements, as of the date of this report, the majority of the medium and high priority Properties of Concern are located along a segment of State Road 231 that stretches from the north side to the south side of Jasper, Indiana; this roadway segment would be included in Alternatives C, M, O, and P and Local Improvements 2, 3, and 4. Medium and high priority Properties of Concern are also present along other segments of the alternatives (as shown in the provided Figures). Additional properties resulting in a low, medium, or high level of concern may be identified during Tier 2 studies. Additional investigations will occur for the preferred alternative and all identified Properties of Concern. The typical INDOT hazmat review process will be undertaken during future stages of the project.
